#### **CORRESPONDENCE**

1st ITEM: Mr. Gianforte reported that the Authority received a thank you note from the MacStudy family for the sympathy gift basket.

**2<sup>nd</sup> ITEM:** Mr. Gianforte explained that the Authority is in discussions with AcuteCare about Connection Fees. Discussion ensued.

<u>3rd ITEM:</u> The Authority received a retirement letter from Sharon Ham, as her planned retirement date will be effective September 1, 2024.

4th ITEM: The Authority received their first bill under the 2035 Heath Care Plan after switching from the NJ Direct 10, and the bill is \$17,000.00 less per month than in the past which will be offset by any claims of the Difference Card.

5<sup>th</sup> ITEM: Brian Rischman explained that the Authority received a letter from the NJDEP. It was a follow-up to their regular annual inspection in April, where items were discussed with the Inspector at that time and changes were implemented to address them. The first item is the annual priority Pollutant Scan. It has been completed annually as required by the DEP, but they also require it to be completed in different quarters each year. So, future tests will be scheduled in different quarters and an extra set of tests will be completed so that it is completed in at least one of each quarter during the period.

The second item found is the DEP requires annual reporting of the treated wastewater used to clean process equipment and tanks. The Authority uses non-potable water, rather than paying the water company, for certain activities. So now the volume will be calculated and reported to the DEP annually as requested.

There was also a deviation from the number of pH and temperature samples taken. The permit requires 3 samples per day or 1100 samples per year. One of those samples was missing. Within two weeks, all Operators were retrained and a system of checks and balances on the evening shift now verifies that the correct number of samples are obtained and tested, and if the correct number is not, they perform the work to maintain compliance and let management know. Mr. Jaeger asked questions regarding the testing frequency and procedures. Discussion ensued.
